32.01.030 Prohibited acts

(b) The city or its duly authorized agent shall have the exclusive right to gather and collect garbage, yard refuse, recyclables, and other solid waste within the city.

It shall be unlawful for any person, except as otherwise provided in this chapter, to gather or collect garbage, yard refuse, recyclables or other solid wastes within the city.

Pursuant to California Public Resources Code Section 40059, the city reserves the right to issue an exclusive franchise for the handling of solid wastes.

Notwithstanding any other provisions set forth in this chapter to the contrary, the exclusive right shall exclude:

- (1) The collection, transportation, recycling, and disposal of any Solid Waste otherwise within the scope of this chapter which is transported to an appropriate disposal facility by an officer or full-time permanent employee of the commercial, construction, or industrial enterprise that generated the Solid Waste (but not including any independent contractor, non-employee agent, or representative, or other contractor of such enterprise.
