Quarterly Activities/ Project Description	Purpose: To provide Americans with Disabilities Act improvements to public facilities and services to seniors and persons with disabilities. At the end of this quarter (September 2010) the results include 61 curb cut ramps have been installed, 19 existing ramps and 12 crosswalk pass-throughs have been brought into Americans with Disabilities Act compliance benefiting 1,029 persons with disabilities completing the curb cut and pathway component of the grant. Also, 125 persons have received information about using public transit and individual mobility training has been completed for 32 persons. 1,362 hours of support services has been provided to 57 individuals that needed assistance due to their disabilities completing the Reasonable Accommodation program. Lastly, 32 individuals with mental disabilities received in-home training and support by a Housing Coordinator allowing them to live independently. The public services component of the grant has been completed.
