**1. Approval of agenda.**

**5. Staff, City Council, Commission communications.**

A. **Final Reports from 2008 Contracts.** Staff B. Reich handed out some of the final reports received from 2008 grant recipients.

B. **Suggestion for Commission regarding metal storage box on 1<sup>st</sup>/E Street.** Staff C. Dyer shared input from City Hall at the Market, regarding a request for the Civic Arts Commission to create a public art piece using the metal storage box on 1<sup>st</sup> and E Street. The item will be put on a future agenda for discussion.

C. **Display at Davis Art Center of a bronze sculpture of a birdwatcher.** Staff C. Dyer announced the offer from artist, Carolyn Underhill, to loan a bronze sculpture of a birdwatcher to the Public Art collection. The piece will be on display at the Art Center through January. The item will be put on the February agenda for formal discussion.

**6. Staff Recommendation for Pence Gallery Contract.** The Commission reviewed staff's recommendation that the Pence Gallery Contract continue through the end of the fiscal year. The item will be on the City Council agenda for January 27. Commissioners Engoron and Hutchins will attend the meeting to represent the Civic Arts Commission.

**7. 2009 Arts Contract Applications: Final Recommendations.** The Commission reviewed the additional information provided by specified applicants, and made final recommendations for this year's \$18,500 in funding.

**Action:** Commissioner Smith moved and Commissioner Stone recommended to approve the contracts as listed below and to bring budget information to the February meeting regarding replacement of the Animals in Heaven mural by the original artist. Motion passed unanimously.
