City of Davis Clearstream Recyclers Rental Agreement

This Agreement is between the person signing it, or the business or non-profit representative signing it and the City of Davis Public Works Recycling Program. You understand that these Terms will apply to each Clearstream Recycler you are borrowing.

By signing this form:

- A. You acknowledge that your **event takes place within Davis city limits.**
- B. You acknowledge that **the Clearstream Recyclers are the property of the City of Davis** and must be returned as specified above.
- C. You acknowledge that you are capable of picking up, setting up, taking down, **recycling the materials collected** and returning the Clearstream Recycler(s) as is required in the terms.
- D. You agree that the City of Davis has the right to verify that your business, drivers or non-profit license has been validly issued and is in good standing; and that we may refuse to rent to you if your license has been suspended, revoked or otherwise restricted in any way.
- E. **You acknowledge that you are 18 years or older and that you are assuming responsibility for the Clearstream Recycler(s) that you are renting.**
- F. **You agree to return the Clearstream Recycler(s) to us in the same condition you received it/them, ordinary wear and tear accepted, on the date and at the time specified by you at the time of reservation. You may not return Clearstream Recycler(s) when the Public Works Department is closed.**
- G. **If you wish to extend the date and/or time of a rental you must contact us at (530) 757-5686 to request it before your return date.** We may or may not grant an extension or could decline to rent it for the entire period you requested by our sole discretion.
- H. You agree that **you must make a reservation for each rental at least three business days prior to the scheduled time of rental.**
- I. The rental commences when you pick-up the Clearstream Recycler(s) from us. You understand that you may be required to show a driver's license for signature comparison at the time of rental.
- J. **We may repossess the Clearstream Recycler(s) anytime if it/they are found damaged, mistreated, or being used to violate the law or this Agreement, or appear(s) to be abandoned.** We may also repossess Clearstream Recyclers anytime we discover you made a misrepresentation to obtain the Clearstream Recycler(s). You agree that we need not notify you in advance.
- K. Certain uses of the Clearstream Recycler(s) and other activities you or a representative may do, or fail to do, may violate this Agreement.
