6A. Consider Recommendation to Change Meeting Date for the Recreation and Park Commission Monthly Meetings.

The Commission received a brief report from Assistant Director Christine Helweg on the proposed changes being recommended by staff in order to improve the public's accessibility to Commission proceedings.

A motion was made by T. Westlund, seconded by C. Greenwald, to change the regular meeting day, time and location to the 3rd Wednesday of each month beginning at 6:30 pm at the Community Chambers.

6B. Consider Proposed Improvements to the Davis Senior Center Patio

The Commission received a brief report from Assistant Director Christine Helweg on the background and history of the Senior Center Patio Expansion project. HDR Consultant Jeff Lawrence then presented a powerpoint presentation on the proposed modifications being recommended for the patio project.

Commissioners had specific comments/concerns regarding the proposed modifications:

- Wanted to ensure that any permanent seating in ADA compliant
- A flat surface or concrete was preferred over pavers or uneven surfaces that could contribute to falls
- City could consider side coverings on the main shade structure for additional weather protection
- City could consider a raised platform or performance stage
- City should consider the addition of ceiling fans in addition to the outdoor heaters for more desirable year-round use

A motion was made by T. Westlund, seconded by C. Greenwald, to approve the proposed conceptual design plan for the Senior Center Legacy Patio Expansion project.

A second motion was made by V. Richter, seconded by C. Greenwald, to approve the proposed conceptual design plan for the Senior Center Legacy Patio Expansion project, with particular emphasis on the integration of public art into the structural, architectural, and

landscape design. Potential areas where commissioned art could be integrated may include wall murals, metalwork on the fencing, ceramic or mosaic water feature, glass tile inlay on seats/counters/walls, decorative seating, terrazzo flooring, or other artistic features.

The motion passed with a 5-1-2-0 vote.

6C. Review and Provide Feedback on New Temporary Sign and Banner Policy

Assistant Director Christine Helweg provided the Commission with a brief report on the history and background on the new proposed policy. After lengthy discussion about types of signage, locations, content of the application form, the Commission decided that it did not want to move forward with a policy for temporary signage or banners in City parks and recreational facilities.

No further action is being recommended by the Commission at this time.

6D. Designate Commission Representative to Serve as Liaison to the Open Space and Habitat Commission for the 2017 Calendar Term

The Commission was unable to identify a single representative to serve as the liaison to the Open Space and Habitat Commission, so it was decided that the position will be shared by Commissioners Greenwald, Hubbard, Pitesky and Richter. Commissioner Pitesky was selected to attend the June meeting. Staff will bring a calendar back in June for assignments for the remaining months in the 2017 calendar year.
