#### 1. Approval of the Agenda

# 5. 2015 Explorit Science Center Annual Report

Executive Director, Lars Anderson, provided the Commission with an overview of the programming that the center provided over the past year, in addition to several grants that had been secured to assist in completing some necessary facility improvements and specialty programs. Mr. Anderson also spoke about upcoming goals for 2016-2017. The Commission was pleased to hear of the increased maintenance to the facility and the increasing sustainability of the programs offered by the center. No action was taken as this was an informational item.

#### 6. City Building and Park Facilities Assessment

Parks & Community Services Director, Dale Sumersille, provided an overview of the Facility Assessment and the draft Executive Summaries for both the Buildings and Park Facilities. Additional information will be brought back to the Commission in April regarding potential 5-year funding recommendations. No action was taken as this was an informational item.

Commissioner Bray expressed concern about the poor condition of the Explorit buildings as evaluated by the Kitchell report, despite maintenance efforts by the Explorit organization. He suggested review of the lease agreement with the City to clarify specific maintenance responsibilities going forward and the actual cost to the City of such lease agreements.

Commissioner Emily Griswold excused herself from the meeting at the conclusion of this agenda item as she was not feeling well.

## 7. 2013 Veterans Memorial Center Feasibility Study and Rehabilitation Proposal

Superintendent Christine Helweg provided a historical overview of the Veterans Memorial Center Feasibility Study and the previous recommendations that the Recreation and Park Commission had provided in January 2013.

Victor Burbank, Hibser Yamaguchi Architects, provided a more detailed summary of the specific recommendations that had resulted from the Feasibility Study, and their associated cost estimates. Mr. Burbank also provided information about the revised scope of work that is currently being considered by the City in lieu of the Feasibility Study.

The Commission expressed interest in continuing to seek ways to expand bicycle parking in and around the facility, and alternative uses of the interior courtyard. Commissioners Ira Bray and Travie Westlund also expressed concern that the proposed funding sources should not be used for this specific project.

A motion was made by Cecilia Greenwald, seconded by Ira Bray, to receive the final Veterans Memorial Center Feasibility Study report prepared by HY Architects, and to approve a recommendation to the City Council to proceed with the Veterans Memorial Center renovation project consistent with the Phase I Rehabilitation Proposal by HY Architects dated October 2, 2016. Further moved that the City Council direct staff to continue exploring expanded teen programming at this location.

The motion passed 5-1-1-1.
