



Water Assistance Program

What is the Water Assistance Program?

The water assistance program provides income qualified homeowners with a discount on their water bill.

Who is Eligible?

Homeowners who meet the income qualification requirements and who are enrolled in Pacific Gas & Electric's (PG&E) CARE Program are eligible. A homeowner is the owner-occupant of a parcel in Davis who is listed as the owner on the assessor's tax roll.

Water Assistance Program Guidelines:

- This program is limited to a maximum of 250 customers annually.
- Owners must be participating in the PG&E CARE Program and have proof of participation.
- Following enrollment, you may be selected for income verification and must provide proof of qualifying household income in order to remain in the program.
- You must notify the City of Davis if your household no longer qualifies for the discount.
- You are required to recertify your eligibility every year.

How Do I Apply?

- **Submit a copy of your proof of eligibility/participation in the PG&E CARE program with your application**

Total combined household income means: gross income, wages, tips, social security, interest, dividends, pensions, annuities, SSI/SSP, rental income, self-employed business income and capital assets income for all household members. You may be selected for income verification and must provide proof of qualifying household income in order to remain on the program.

“**Household member**” is any and all persons living in the residence at any time during the tax year including co-owners named on the tax role. Co-owners are considered household members whether or not they reside in the home.
