Part a: Thomas Adams from Avenu Insights provided a background and analysis for sales tax at City, Regional, and State Level.

Part b: Elena Adair provided an update on FY19/20 major revenues sources Public Comment:

<u>Matt Williams-</u> Where in the revenue that has been recognized shown in the revenue chart? Isolate the COVID-19 impacts. See the very specific impact of COVID-19. It is very important to have revenues, costs, and bottom line fund balance. Provide cash flow analysis. Saved money by eliminating services. Where service levels have declined so people can see what the impact is on their lives.

B. Update on Committee Proposal related to early payment of OPEB and Pension liabilities from specified enterprise funds. (15 minutes) Finance Director Elena Adair provided a brief update on the status of the proposal received from the Fund Balance and Revenue Sub Committee at the July 13th, 2020 meeting. The commission also received advice from the city attorney, indicating that the committee's recommendation can be done lawfully, as long as the City properly accounts for the payments. Finance Director Adair indicated that it would be necessary to hire an actuary to perform the necessary calculations, and Commissioner Salomon requested the documents from City staff that are used to perform the OPEB/Pension liability calculations.
