**SUBJECT:** Summary of Results - Open Space Survey

#### Recommendation

This item is informational and staff does not have a recommendation.

#### **Background/Analysis**

In 2018, the Davis City Council passed a Strategic Plan for the City's Open Space Program ("Strategic Plan"), which provides a clear roadmap for preserving and managing open space in and around the City of Davis through 2030. The Strategic Plan focuses on six key subject areas: (1) Acquisitions, (2) Habitat Restoration and Enhancement, (3) Land and Resource Management, (4) Public Access and Recreation, (5) Financial and Program Accountability, and (6) Public Engagement and Partnerships. One of the key action items in the Strategic Plan is to reach out to the community for feedback every five years. The last time the City reached out to the community on this subject was in 2016. The feedback received in 2016 influenced and shaped the Strategic Plan, which shifted the City's efforts to focus more on public access and recreation, habitat restoration, accountability and transparency, and public engagement and partnerships.

In 2021, staff worked with the Commission to develop an on-line survey to gather additional feedback from the community. The survey was organized by the Strategic Plan's six key subject areas. It covered various aspects of the Open Space Program, including the program's acquisition strategy, its focus on habitat restoration and public access and its efforts to engage the public in the stewardship of the City's open space areas. It was released on October 18, 2021 and closed on November 19, 2021. The City received 288 responses. The following briefly summarizes the results.

#### Results of Open Space Survey

The following briefly summarizes the results from each section of the survey. The full survey results can be reviewed in Attachment 1.

#### **General Questions**

On the down side, very few respondents were familiar with the Open Space Program or were aware that program information was available on the City's website. On the up side, the vast majority of respondents said they visit one or more of the City's open space areas on a regular basis.

Also, half of the respondents did not know that Measure O funded the acquisition and maintenance of the City's open space areas. Despite this fact, more than 70% of the survey respondents said they would vote to renew Measure O in the future.

Highlights of this section include:

- More than 75% of respondents said they were only "somewhat familiar" or "not so familiar" with the Open Space Program. Another 12% said they weren't sure and would like to know more.
- More than 65% of respondents said they regularly visited an open space area.
   The Putah Creek Parkway, the North Davis Upland Habitat Area, and the Wildhorse Agricultural Buffer were the three most visited sites.
- There is still confusion about what constitutes an open space. Several people cited the North Davis Channel and the Davis Wetlands as "open space areas" that they visited regularly, not realizing that these sites are public works facilities and not part of the City's Open Space Program.
- Nearly 75% of respondents didn't know there was information about the City's Open Space Program on the City's website, or couldn't find it.
- Those who did know there was information about the City's Open Space
  Program on the City's website most often looked up information about the City's
  open space areas and information about the history of the City's open space
  program and Measure O.
- Only about half (50%) of the respondents knew that Measure O helped fund the
  acquisition and maintenance of the City's open space areas. Despite this, more
  than 70% of the respondents said they would vote to renew Measure O. Only
  6% said they would vote "no" on Measure O renewal. About 24% said they were
  not sure if they would support renewal or not.

#### **Acquisitions**

There is widespread support for purchasing farmland near the city limits that also has some habitat/recreational value, such as land along waterways like the South Fork of Putah Creek (84% support). There is also widespread support for purchasing agricultural conservation easements on farmland near the city limits to protect land within a mile of the city limits (78% support).

#### **Habitat Restoration and Enhancement**

There was widespread support for creating new habitat areas that are also accessible to the public, such as the North Davis Upland Habitat Area (85% support). There was also

widespread support for installing hedgerows of native plants on City-owned agricultural land to enhance the wildlife habitat value of these lands (86% support).

#### **Land and Resource Management**

There was widespread support for designing and installing new signs in all of the City's open space areas to better identify these areas and describe each area's unique characteristics (80% support). There was also widespread support continuing to lease agricultural land to responsible commercial farmers to earn revenue for the City's Open Space Program (72% support). About 35% of the 57 people who wrote in comments expressed a preference for organic farming practices on City agricultural land.

#### **Public Access and Recreation**

Less than half of the respondents (only 47%) were aware of the new trails and public accessibility improvements at South Fork Preserve and the North Davis Upland Habitat Area. Nevertheless, 60% of respondents said they approved of these new trails and public accessibility improvements (only 5% said they did not approve).

The top three public accessibility improvements respondents said they would like the City to focus on over the next several years were:

- 1. increase the availability of formal hiking trails (72%),
- 2. increase the number of safe bike/pedestrian and transportation connections between publicly owned open space areas (59%), and
- 3. install new and improved educational signage about the open space area and its usage rules (32%).

#### **Financial and Program Accountability**

Most respondents (64%) could not say whether the City's Open Space Program was being managed well. About 27% of respondents said the program was being managed well or fairly well. Only about 5% of respondents said the program was not being managed well.

Most respondents (61%) also said they didn't know if there was enough information on the City's website to determine if staff were managing the City's Open Space Program efficiently and effectively. More than 20% said there was enough information. Only 11% said there was not enough information.

#### **Public Engagement and Partnerships**

About 60% of respondents gave the City suggestions for ways to better advertise its open space areas and its Open Space Program. The other 40% (115 people) skipped this question. All the responses to this question can be seen in Attachment 1. Some of the suggestions included (1) including information about the program in mailings, such as with the Greener Davis newsletter and/or with the utility bill, (2) installing additional signage, (3) increasing the program's social media presence, (4) entering open space

locations into Google, and (5) getting the *Davis Enterprise* to feature an open space area as part of a regular series about the program.

Sixty-five (65) of the respondents said they would be willing to volunteer their time to help maintain the City's open space areas. Eighteen (18) respondents left their emails.

About 47% of respondents gave the City suggestions for organizations to partner with. The other 53% (152 people) skipped this question. All the responses to this question can be seen in Attachment 1. Some of the suggestions included (1) the Yolo Audubon Society, (2) local scout troops, (3) sorority and fraternity organizations, (4) the Davis Joint Unified School District, (5) service clubs such as the Rotary Club and the Oddfellows, (6) the Sierra Club, and (7) the Center for Land-Based Learning.

#### **Conclusion/Next Steps**

In general, the survey results show general support for the current direction of the Open Space Program, and the action items in the Strategic Plan. The survey also shows continued strong support for Measure O, the City's special open space parcel tax.


However, the feedback also exposed a few areas that need improvement: (1) very few people are familiar with the Open Space Program and what it does, (2) people still seem to be confused about what constitutes an open space area, and (3) very few people know that information about the Open Space Program exists on the City's website.

Staff would like to have further discussions with the Commission about these three areas and what can be done to address them. Staff will post this staff report, along with the full results of the survey (with email addresses redacted), on the City's website.


## Q1 GENERAL - QUESTIONS 1-5How familiar are you with the City of Davis's Open Space Program (please check one)?










