

**RESOLUTION NO. 22-126, SERIES 2022**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DAVIS DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW OF THE SPECIAL MUNICIPAL ELECTION HELD ON JUNE 7, 2022**

WHEREAS, a Special Municipal Election was held and conducted in the City of Davis, California, on Tuesday, the 7th day of June, 2022, as required by law; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provide by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form, and manner as required by the provisions of the Election Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the County Clerk of the County of Yolo canvassed the results of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Davis does resolve as follows:

Section 1

1. The total number of votes cast including vote-by-mail, precinct, and absentee voting ballots was 19,787.
2. The number of vote center votes cast was 128.
3. The number of vote-by-mail votes cast was 19,005.
4. The number of conditional voting votes cast was 77.
5. The number of election day voting votes cast was 577.

Section 2 The Special Municipal election was held for the purpose of submitting the following measure to the electors of the City as required by the laws relating to cities in the State of California:

Measure H – Shall Resolution 22-010 be adopted to approve a mixed-use innovation center with lab and research facilities, offices, market-rate and affordable housing, hotel/conference center, parks, and community sports fields, by amending the City of Davis General Plan to change land use designations for the Davis Innovation and Sustainability Campus 2022 (DiSC 2022) and Mace Triangle properties from Agriculture and Public/Quasi-Public to Innovation Center, Urban Agriculture Transition Area, General Commercial and Public/Semi-Public, and establishing Baseline Project Features?

Section 3 The number of votes cast for and against Measure "H" were as follows:

Section 5 The City Council does declare and determine that Measure "H" was not approved by the voters and shall not be deemed adopted and ratified.

Section 6 The City Clerk shall enter in the records of the City Council a statement of the results of said election, showing: (1) the total number of votes cast in the city; (2) the measure voted upon; (3) the number of votes given for and against each measure; and (4) the total number of votes for and against each measure.
