RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DAVIS DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW OF THE ALL-MAIL BALLOT SPECIAL MUNICIPAL ELECTION HELD ON MAY 2, 2023

WHEREAS, an All-Mail Ballot Special Municipal Election was held and conducted in the City of Davis, California, on Tuesday, the 2nd day of May, 2023, to fill a vacancy on the City Council and elect one (1) Member of the City Council in District 3 for the term of office in which the vacancy was created which ends December, 2024, as required by law; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provided by law; that candidates were nominated to fill the vacancy or vacancies as provided by law; that voting precincts were properly established; that election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form, and manner as required by the provisions of the laws of the State of California for the holding of elections in general law cities; and

WHEREAS, the County of Yolo Elections Department canvassed the results of the election and has certified the results to the City Council, the results are received, attached and made a part hereof as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Davis does hereby resolve as follows:

Section 1.

The number of ballots cast for City Council Member in District 3 was 2,413.

- A. The number of vote by mail ballots cast was 2,413
- B. The number of conditional ballots cast was 0

<u>Section 2.</u> The Special Municipal Election was held for the purpose of electing one member of the City Council in District 3 for a term expiring upon the election of the successor thereto at the general election in November 2024.

<u>Section 3.</u> The names and number of votes cast for the nominees for members of the City Council are as follows:

<u>Section 4.</u> The City Council does declare and determine that Donna Neville was elected as member of the City Council for District 3 for a term expiring upon the election of the successor thereto at the general election in November 2024.

<u>Section 5.</u> The City Clerk shall enter in the records of the City Council a statement of the results of said election, showing: (1) the whole number of ballots cast in the city; (2) the names of the persons voted upon; (3) the office for which each person was voted for; and (4) the total number of votes given to each person.

<u>Section 6.</u> The City Clerk shall deliver to each person elected a Certification of Election signed by the City Clerk and duly authenticated; and shall administer or authorize deputies to administer to the persons elected the Oath of Office prescribed in the Constitution of the State of California and shall have those persons subscribed thereto, whereupon each person so elected shall be inducted into the office to which they have been elected.
