Methodology



- Multi-modal Email- and Text-to-Web/live telephone survey of likely November 2024 voters
- Survey conducted October 25-November 1, 2023
- 400 interviews; overall margin of error ±4.9 percentage points
- Interviews were conducted in English by trained, professional interviewers; landlines and mobile phones included
- Where applicable, results compared with the following:

Please note that due to rounding, some percentages may not add up to exactly 100%.

Key Findings



- Davis voters are optimistic about the direction of the city and most are satisfied with City government.
- A majority of voters recognize the City's need for additional funding and are willing to increase taxes to maintain services.
- Affordable housing, homelessness, and crime/public safety are top-of-mind issues for voters.
- As it stands today, support for a potential measure is well above the threshold.
- Maintaining public safety response, roads and bike paths are top tier priorities for voters.




Issue Environment

Respondents remain optimistic on the direction of Davis.





Most Important Problem – Tracked



Affordable housing remains the top issue identified by voters, followed by homelessness and crime/public safety.





Voters' satisfaction with the provision of city services remains strong.





Tax Attitudes Over Time




Davis voters are open to tax increases for City services. Most voters trust the City's management of tax dollars, although intensity has decreased since 2019.


Ballot Measure

Sales Tax Initial Vote



Three-quarters of voters support a potential sales tax measure.


To fund essential city services, such as public safety and emergency response; crime prevention; city road, sidewalk, and bike path maintenance; homelessness services and affordable housing support; and greenhouse gas reductions, shall the City of Davis Ordinance be adopted establishing a 1¢ sales tax, providing approximately \$10,000,000 annually for general government use until repealed by the voters, subject to annual review, public disclosure of all spending and with all funds staying local?



Measure Components




Public safety, affordable housing support, maintaining roads, sidewalks and bike paths, and improving homeless services are among the top priorities tested.



Measure Components




Other components are also important to most, but with lower intensity.



Additional Information



Information around exemptions and accountability features is especially compelling to voters.




Q26-35. Please tell me how convincing that statement is as a reason to vote for the measure – very convincing, somewhat convincing, not too convincing, or not at all convincing.

Other information is also convincing, but with lower intensity.




Q26-35. Please tell me how convincing that statement is as a reason to vote for the measure – very convincing, somewhat convincing, not too convincing, or not at all convincing.

Vote Progression



Measure support does not change following additional information, but drops following potential opposition messaging.




Measure Vote Progression



The inclusion of a sunset clause in the measure has little impact.


What if the measure we have been discussing automatically expires in 9 years instead of continuing until repealed by the voters, would you vote yes to approve or no to reject this measure?



Historical Context



Initial support for the potential measure is similar to support seen in polling for Measure Q.



Conclusions



- Support for an additional 1¢ sales tax begins in a strong place, similar to support seen in polling prior to the Measure Q sales tax extension.
- Support does not increase further after additional information, suggesting initial support may already be at the ceiling in the current environment.
- Many of voters' priorities are included among measure components.
- ▶ While a potential measure is somewhat vulnerable to opposition, support remains well above the passage threshold in the current landscape.
