



**NOTICE OF ELECTION AND FINAL DATE FOR FILING ARGUMENTS FOR OR AGAINST CITY MEASURE TO BE SUBMITTED TO THE ELECTORS OF THE CITY OF DAVIS ON NOVEMBER 5, 2024**

NOTICE IS HEREBY GIVEN that a General Municipal Election will be held in the City of Davis on Tuesday, November 5, 2024, for the following Officers and Measure:

- For One (1) Member of the City Council – District 2 (Full term of four years)
- For One (1) Member of the City Council – District 3 (Full term of four years)
- For One (1) Member of the City Council – District 5 (Full term of four years)

<b>City of Davis Essential Services Measure</b>	
To support essential City services, such as public safety and emergency response; crime prevention; pothole repair; parks, road, sidewalk, and bike path maintenance; and addressing homelessness, affordable housing, and climate change, shall the City of Davis’s Ordinance be adopted establishing an additional 1¢ sales tax providing approximately \$11,000,000 annually for general government use until repealed by the voters, subject to annual audits, public disclosure of all spending and with all funds staying local? The nomination period for these offices begins on July 15, 2024, and closes on August 9, 2024, at 5:00 p.m.

If nomination papers for an incumbent officer of the city are not filed by August 9, 2024 (the 88th day before the election) the voters shall have until the 83rd day before the election, August 14, 2024, to nominate candidates other than the person(s) who are the incumbents on the 88th day before the election, for that incumbent’s elective office. This extension is not applicable where there is no incumbent eligible to be elected.

If no one or only one person is nominated for an elective office, appointment to the elective office may be made as prescribed by § 10229, Elections Code of the State of California.

NOTICE IS FURTHER GIVEN that the City Attorney will prepare an impartial analysis for the Measure showing the effect of the measure on existing law and the operation of the measure. The impartial analysis must be submitted **no later than 5:00 p.m. on July 8, 2024.**

NOTICE IS FURTHER GIVEN that the City Council, or any member or members thereof authorized by the City Council, or any individual voter or bona fide association of citizens, or any combination of voters and associations, **may file a written argument for or against the city Measure.**

Arguments must be submitted to the City Clerk, 23 Russell Boulevard, Suite 1, Davis, CA, 95616, **no later than 5:00 p.m. on July 18, 2024**, which has been determined by the elections official to be a reasonable date based upon the time necessary to prepare and print the arguments and Voter Information Guide for the election.

No argument shall exceed 300 words in length and **must be accompanied by the printed name(s) and signature(s) of the author(s) submitting it**, or if submitted on behalf of an organization, the name of the organization and the printed name and signature of at least one of its principal officers who is the author of the argument, for or against the Measure.

One argument for and one argument against the Measure will be selected for printing and distribution to the voters with the sample ballot. Arguments may be changed or withdrawn until and including the date fixed by the City Clerk.

NOTICE IS FURTHER GIVEN that **rebuttal arguments may be submitted by the authors of the opposing direct arguments no later than 5:00 p.m. on July 29, 2024**. Rebuttal arguments may be submitted by the author or a majority of the authors of an argument or the author(s) may authorize in writing another person or persons to prepare, submit, or sign a rebuttal argument.

No rebuttal argument shall exceed 250 words in length and **must be accompanied by the printed name(s) and signature(s) of the author(s) submitting it**, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument.

NOTICE IS FURTHER GIVEN that any impartial analysis, direct argument or rebuttal argument filed under the authority of the California Elections Code will be available for public examination in the City Clerk's Office for not less than 10 calendar days from the filing deadlines.
