- (b) Containers located at multiple stations on one occupancy shall be considered separate services, unless the locations and access to the multiple stations expedite waste collection.
- (c) Containers stored in difficult-to-service locations shall be serviced at a surcharge rate negotiated between subscriber and the City or its fully authorized agent.
- (d) Containers filled or holding compacted garbage cubes will be charged weight maintenance surcharge per above.

(3) Commercial "No Garbage" billing (all services except actual garbage collection): 16.27 per month

(4) A vacant business or vacant communally serviced residence shall be entitled to the "No Garbage" rate, providing notice is given to the City at the start of the vacancy period.
