Other than our third party service providers (such as our hosting service), your child's name will not be shared with any third parties. Your child's user name, gender, teacher/classroom, grade level, method of transport to and from school, and certain statistics (trips to and from school, total distance traveled, related estimates of environmental and monetary/fuel cost savings) will be shared on his or her school "mini-site," which is accessible only with a unique password assigned by the school's program administrator and provided to students, parents, teachers and any other personnel authorized by the school. You may review the information and ask to have it deleted, and prevent future collection and use of information, at any time by contacting us. We do not require children to disclose more information than is reasonably necessary to participate in our service.
